M-312 must be supported

Parliament is scheduled to resume on September 17 and the second hour of debate for Stephen Woodworth's (CPC, Kitchener Centre) private member's motion, M-312 is set for September 21, followed by a vote on September 26. M-312 calls upon Parliament to set up a committee to examine the medical and scientific evidence of life before birth and to consider the human rights implications of those findings. Technically, the bill is not about abortion (unless the committee wants to examine that issue) but the opposition parties and media have predictably treated it as an abortion bill. During the first hour of debate in May, Gordon O'Connor, the chief government whip, gave a vehemently pro-abortion speech, but because of his party position it was widely reported as a signal from the Prime Minister's Office that Stephen Harper wants his caucus to defeat M-312. In June, various media outlets reported that Conservative caucus members have been pressured by the PMO to vote against the bill.

It is vital that each and every one of us contact your MP and urge him or her to vote for M-312. Amazingly, several MPs have told CLC they have not heard from constituents on this currently highest priority pro-life motion. That is not good. We cannot let MPs think the pro-life community does not care about this motion. We are fearful that if M-312 – which only calls for an examination of scientific evidence – is soundly defeated, other MPs would be reticent about bringing forth other pieces of pro-life legislation, worried that it has no chance of passing and that support from the pro-life

grassroots can't be counted on. By far the greatest strength of this movement has been the actions of grassroots supporters at the local levels. Without that CLC is utterly powerless to effect any change for good. We provide you with information and direction, but it is your direct actions that actually make things happen.

It is important that M-312 receives a strong showing to demonstrate to all the political leaders that Canadians are ready for a political debate on abortion. Contact your MP, regardless of their party affiliation, right away. Try to meet with your elected representatives, but if that is not possible, call or mail them to let them know you want M-312 to pass. If half of those present in the House of Commons do not support M-312, it will be defeated and there will be no more discussion of it in Parliament.

Doctors put politics ahead of science

The Canadian Medical Association, an organization representing more than 76,000 Canadian physicians, recently re-affirmed their pro-abortion mantra at their annual council meeting on Wednesday, August 15th, 2012, in Yellowknife, N.W.T., by officially opposing MP Stephen Woodworth's Motion 312. This activist organization urged its members to pressure the government to vote against the motion "so that this motion has no chance of being passed and the debate is not reopened," as stated by Dr. Geneviève Desbiens, a Montreal physician. A "medical association" doesn't want to debate "medical and scientific evidence" on something that is so

central to their profession; human life. CLC believes that this just shows the sorry state of the leaders of the CMA who have drifted so far from the oath of Hippocrates.

Action Item: Contact your family doctor and urge them to speak out against this political position taken on by the Canadian Medical Association.

McGuinty censors abortion numbers

The *National Post* reported August 10 that Ontario was no longer releasing abortion statistics, noting the provincial Ministry of Health recently restricted public access to records of abortion services because such information is “highly sensitive.” As part of Bill 122, a financial accountability law passed earlier this year, abortion-related statistics – not information about individual patients, but just the number of abortions being committed in the province – will be exempted from the Freedom of Information and Privacy Protection Act. In other words, journalists, health researchers, pro-life groups, or regular taxpayers, will not have access to statistics relating to how many abortions are committed in Ontario.

Last September, we co-sponsored a poll with *The Interim* and LifeSiteNews.com that asked “Do you support or oppose the provincial government requiring clinics and hospitals to disclose all statistics regarding abortion?” About half (48%) strongly or somewhat supported requiring abortion facilities to release that information, while just 23% thought it better not to release abortion statistics; about 30% did not care one way or another. To be clear, nearly twice as many people who had an opinion wanted full disclosure of abortion statistics. The Dalton McGuinty government is headed in the opposite direction and withholding abortion statistics from the people of Ontario.

We wonder why, if abortion is something that the public funds through taxes, it should be completely hidden from view. At the very least, how can there be accountability for how taxpayer dollars are spent? (Our poll last Fall, also showed seven in ten Ontarians want abortion to be fully or partially defunded.) CLC National

President Jim Hughes said, “The secrecy of the McGuinty

government suggests that burying the mounting toll of more than 40,000 babies killed in their mothers’ wombs in Ontario by hiding their records will wipe away the reality of their deaths, but it won’t.”

Mary Ellen Douglas, CLC Ontario President said, “The McGuinty government fully understands the reality of what they are allowing and still refuses to lift a finger to save these babies.” Douglas added: “Abortion kills a human being, hurts women, and is a financial drain on our health care system, and now the government is trying to make it seem like these deaths are not even worthy of being counted.”

Action item: Ontario residents please contact Ontario Premier Dalton McGuinty and your MPP to demand transparency and urge the government to reverse its decision to restrict public access to abortion records and the public spending associated with abortions.

B.C. court upholds assisted suicide exemption

We reported last month that the federal government is appealing the B.C. Supreme Court activist decision of Justice Lynne Smith to throw out the Criminal Code prohibition on euthanasia and assisted-suicide which requires Parliament to rewrite the law by June 13, 2013. That appeal will be heard by the B.C. Court of Appeal March 4-8, 2013. Unfortunately, Justice Jo-Ann Prowse of the B.C. Court of Appeal did not stay Justice Smith’s decision to provide a constitutional exemption to Gloria Taylor, an ALS patient, who asked to be allowed to have a medical professional help her kill herself, which will permit Taylor to seek assisted suicide, if she chooses, before the appeal is heard. Alex Schadenberg, executive director of the Euthanasia Prevention Coalition, said he was concerned that Justice Prowse’s ruling might encourage other patients seeking assisted-suicide to pursue a constitutional exemption in order to “die by euthanasia before the Supreme Court and Parliament have ruled on the matter.” CLC National President Jim Hughes was more stark: “This constitutional exemption amounts to judges deciding who will live and who will die.”

Justice Prowse also ruled that Parliament need not rewrite the euthanasia law by next June, as she allows the case to continue through the courts.

By-elections

There will be Ontario by-elections in Kitchener-Waterloo and Vaughan on September 6. We are in the process of qualifying the candidates. Before residents of these two ridings vote, please check our website, www.campaignlifecoalition.com to find out where the candidates stand on life and family issues. While the media will focus on the storyline of the by-elections holding the fate of the McGuinty government in the voters’ hands – he can gain a majority if the Liberals win both seats – we encourage pro-life voters in these two ridings to put the lives of unborn children first and foremost in their thoughts when they cast a ballot September 6.

Defund abortion mini-rallies

Since the launch of CLC’s Defund Abortion campaign at a major rally last fall at Queen’s Park, we have been hard at work pamphletting constituencies with our educational/political pamphlet, and accumulating signatures for our defund abortion petition. Over 40,000 defund abortion pamphlets have been delivered to constituencies across the province, and over 22,000 signatures have been collected for our petition. Because of this, we are now planning phase two of our campaign. CLC is in the midst of organizing mini defund abortion rallies across the province to happen on the same day, at the same time, to send a message loud and clear to our elected officials, that defunding is an issue Ontarians care about. The date and time

for these rallies is set for October 13th at 11am. We are currently looking for people to do the groundwork for this event. We are hoping to have a mini rally in every constituency across the province. CLC will provide volunteers with everything they need: signs, posters, instructions etc. All we ask is help to oversee the proceedings in the individual cities/towns, and lead the rally. As MP David Anderson (Cypress Hills - Grasslands) said at this year's National March for Life, "you must continue this fight. You can see that it is only when the 70% across this country who want protection for the unborn step forward, that governments will have the courage to actually deal with this issue".

Harper, why the double standard on science?

On August 7, Prime Minister Stephen Harper spoke about the controversial Northern Gateway pipeline from the oil sands project in northern Alberta through British Columbia to the Pacific Ocean. The Prime Minister said: "The only way that governments can handle controversial projects of this manner is to ensure that things are evaluated on an independent basis scientifically, and not simply on political criteria." As CLC Project Manager **Matthew Wojciechowski** noted on the Campaign Life Coalition blog, entitled "An inconvenient science," if Harper wants science and not politics to decide the fate of issues, he applies the standard selectively. "The Prime Minister wants science not politics to decide the fate of so-called controversial issues. And according to him, that's the ONLY way of doing it. Well... only when it's convenient. Case in point: Motion 312. Stephen Woodworth's private member's motion calls upon parliament to re-examine the status of the pre-born child using modern scientific and medical evidence, not political criteria ... yet, the Prime Minister is pressuring his caucus to oppose the motion." Stephen Harper has always wanted to avoid the issue of abortion, allowing the abortion status quo of more than 100,000 babies killed in utero every year, and will not even permit a scientific discussion about the humanity of the child in the womb - ditto the Liberal and NDP party.

Gestational limits not supportable: evangelical professor

Scott Masson, a professor at Tyndale University and a Fellow at the Ezra Institute of Contemporary Christianity (a Toronto-based evangelical organization that addresses cultural issues) has weighed in on the debate in Canada about gestational legislation. Professor Masson told LifeSiteNews that he believes gestational limits to abortion to be morally wrong because such laws give man – not God – the authority over life and death. He said: "While everyone would grant the merit in saving as many babies as possible, and thus acknowledge that is better to save some than none, what this comes down to is the essence of the pro-life position: it is not man but God alone who determines what life is, and where it begins and ends." Masson added: "As soon as we collapse God's absolute

sovereignty over life into areas of prudential judgment, we endorse a pernicious form of relativism and thereby 'co-operate with evil'." Furthermore, he asked, "By what standard shall we judge the gift of life without blaspheming the goodness of the Giver?" Masson endorsed just incremental legislation to restrict abortion until the day all abortions can be outlawed, as long as it was done "without endorsing any abortion at any time in any way."

Mary Wagner arrested

On August 16, Mary Wagner, accompanied by fellow pro-life activist Leeda Crawford, was arrested after encouraging women at the Women's Care Clinic in Toronto to not abort the babies inside them. Mary successfully followed someone into the abortuary waiting room only to be physically removed by two employees. While they were waiting for the police, a young woman accompanied by a friend was making her way into the clinic, Wagner quickly moved towards the young woman offering her a rose and prayers. A clinic employee interfered shouting "Don't listen to her" at the young mother. Police arrived shortly after. That same afternoon, Wagner was kept in the holding cell at College Street court house until after 4 p.m. When the court finally addressed Mary, the prosecutor said in a firm voice; "We will not consider release of this woman. She has broken two standing court orders which tell her not to go near abortion clinics. In defiance she continually ignores these orders. There are no conditions under which we will release Miss Wagner." Mary Wagner remains in custody at the Vanier Centre for Women, 655 Martin Street, Milton, ON L9T 5E6

The CLC National Office in Toronto will administer CLC B.C. on behalf of the National Board until a new leader is announced in the Fall. A search committee has been struck to review potential successors.

Campaign Life Coalition will continue to work together with leaders and grassroots supporters throughout British Columbia to nominate and elect pro-life political candidates, lobby incumbents and strive for life-protecting government policies for all human beings from the moment of conception to natural death. CLC B.C. will also continue to defend the family, the institution best suited for the conception and nurturing of new life and support of the aged.

Brulotte believes that the National March for Life will awaken the conscience of the nation in Canada, and hopes her video can make a difference too. "I will leave this world knowing I did my best," she said. "My dream is for everyone to feel the same way about this issue."

40 Days for Life

Numerous communities across North America will have a Fall 40 Days for Life campaign to witness to the injustice of abortion and provide front-line help to women seeking abortions. CLC brought 40 Days for Life to Canada in 2007 (Ottawa and Halifax) after seeing its tremendous success in the United States, where abortuaries closed (some reduced hours, but 23 have closed their doors permanently), abortion workers quit their jobs, and many women and children were saved from abortion. In Canada, abortion facilities have seen the number of women getting abortions reduced over the duration of 40 Days for Life as there have been dozens of lives saved – both child and mother – due to the prayerful pro-life presence and sidewalk counselling. Overall, nearly 6000 babies throughout the world have been saved according to reports, and who knows how many more women turned their back on abortion as a false solution to their situation but who never shared their change-of-mind with those taking part in the vigils.

We need more volunteers. The sidewalk counselling is done by trained staff and volunteers, but we need many more people to stand across the street from the abortuary and quietly pray. We need people to cover every hour from 8 am to 8 pm (when the abortions are being committed). We encourage churches to sponsor a full day (or two) so that they will be responsible for getting congregants to cover each hour of the day. If you cannot take part – perhaps you do not live close to where a 40 Days for Life campaign is taking place – please pray and fast for the success of the vigils.

Since 2007, more than 422 communities have provided this witness, bringing more than 500,000 people together for prayer and fasting for an end to abortion. This Fall, the Canadian cities taking part in the 40 Days for Life vigil are Calgary, Edmonton, Red Deer (Alberta), Terrace, Vancouver, Victoria (British Columbia), Toronto, Guelph, Oakville (Ontario), and Montreal (Quebec).

LifeChain

Depending on where you live in Canada, LifeChain will be held either on Sunday, September 30 or Sunday, October 7. Because the first Sunday of October falls on Thanksgiving weekend this year, many local pro-life groups (but not all) have moved LifeChain to the week earlier, with the endorsement of the U.S. founder and organizer. Please contact your local pro-life group or check the listings in the September edition of *The Interim* for the proper date. Please take a stand against the injustice of abortion by holding a sign for one hour which will communicate to thousands of passers-by that abortion kills an unborn child, abortion harms women, and that there is forgiveness for women who have made a tragic decision to kill their unborn child. The annual event is a silent, peaceful, powerful, pro-life witness seen by hundreds of thousands of Canadians each year as they travel through intersections where LifeChains occur. Please take part in this year's LifeChain.

Chick-fil-A protest and social media

South of the border, there was an incredible show of consumer activism in support of fast food chain Chick-Fil-A after its CEO Bob

Cathy came under attack for upholding the Biblical view of marriage during a recent interview. Gay activists were enraged and called for a boycott of Chick-fil-A and Democratic mayors in Boston and Chicago said the chain was not welcome to expand their restaurants to their cities. There was a backlash ... against the heavy-handed politicians and gay-activists. Religious conservatives were joined by libertarians worried about the over-reach of government objecting to a businessman's private political views in a Chick-fil-A Appreciation Day. The day, August 1, was suggested by radio talk show host Mike Huckabee, a former Baptist pastor and Arkansas governor, who wanted pro-traditional family Americans to show their support for a company under siege. No one expected the outpouring of support for Chick-fil-A, as people posted photos on social media and local television outlets showing long lines of both pedestrians and cars (many nearby streets needed police to direct traffic).

The outpouring of support for a restaurant whose besieged CEO simply reiterated what was the law and common-sense a decade ago, was inspiring and demonstrated how a grassroots movement can spread like wildfire to pushback against government and gay activist bullies. Many Canadian pro-family activists were upset to discover there were no outlets in Canada where they could join in this show of support – we know because CLC received phone calls and emails about how to participate in Chick-fil-A Appreciation Day.

Most of the mainstream media did not report, tried to ignore the massive show of support for Chick-fil-A, or downplayed its significance. But everyone knew about it because customers went to Twitter and Facebook to show the whole world the huge numbers of people filling both stores and surrounding streets. Indeed, Mike Huckabee's radio reach was one thing, but his Facebook page for Chick-fil-A Appreciation Day attracted 600,000 "likes" (supporters). We might complain about media bias, but with the internet, it is easy to get around the censorious news media that deliberately ignore pro-life and pro-family stories. CLC in the media

On August 6, CLC's Jack Fonseca appeared on Michael Coren's *The Arena* on the Sun News Network to discuss a shocking video of a North Carolina abortionist defending his career and congratulating himself on killing the "ugly black babies" he claims no one wants. The racism was shocking, although not terribly surprising. Pro-lifers have long noted that the abortion

industry targets black neighbourhoods, and just as abortionists dehumanize the unborn child to defend their deadly profession, some will no doubt dehumanize black unborn babies by dismissing them as ugly and therefore inferior. Fonseca also addressed a new show to appear this fall on NBC, *The New Normal*. This show will depict a homosexual couple's quest to have a child with the assistance of a surrogate mother and the conflict this causes one of the homosexual's scary, morally conservative grandmother. Fonseca pointed out that this is the latest attempt to normalize homosexuality and homosexual families and paint people of faith who hold traditional values as grumpy, out-of-touch, and even deranged.

The next week, Alissa Golob of CLC Youth, was on Coren's show to talk about Ontario's censorship of abortion statistics and eugenic abortion targeting babies with Down Syndrome. Jack and Alissa are part of rotating threesome of pro-lifers (along with Live Acton's Lila Rose, our 2010 Rose Dinner Speaker at the National March for Life) that will appear each Monday on *The Arena*.

The heroic witness of Nellie Gray, RIP

Nellie Gray, a giant of the U.S. pro-life movement, passed away on the weekend of August 11-12 and was discovered in her home on August 13. She was 86. Once described by Cardinal Sean O'Malley as the Joan of Arc of the pro-life movement, she was the founder of the March for Life in Washington, the largest annual pro-life event in the world. She had a slight frame but she had a huge presence every year hosting the March, introducing pro-life leaders and politicians who addressed the throng who came to Washington every January to mark *Roe v. Wade*.

With a number of friends, Nellie Gray founded the March in 1974 to mark the first anniversary of the Supreme Court decision that legalized abortion. More than 20,000 people attended. CLC modeled the National March for Life in Ottawa on the March for Life in Washington, including incorporating the Rose Dinner banquet and keynote speaker, and like the American version, ours grew slowly but steadily to become, like the U.S. one,

the largest annual demonstration in our nation's respective capital. In some years, CLC added to the numbers in Washington by organizing bus trips to their March for Life.

Fr. Frank Pavone of Priests for Life remembered Nellie Gray as "a tireless warrior for the unborn" whose "motto was 'no exceptions, no compromise'." CLC National President Jim Hughes has attended the March for Life in Washington for years and was one of Nellie's many admirers. He said, "She served as a great example to all of us and showed how to get the pro-life message out to people. She was a woman who was so determined that every little baby that died was on her watch, and she wanted to work as hard as she possibly could and with as much ingenuity to change the situation." Hughes added, "She has left a tremendous legacy and she will be greatly missed." Next year, the 2013 March for Life will mark the 40th anniversary of *Roe v. Wade* decision – and the 39th anniversary of the March.

Life Chain

What is Life Chain?

Life Chain is a prayerful, peaceful, witness to the evil of abortion and to the sanctity of human life from the moment of conception.

Why is it Important?

Life Chain is for one hour, on one day of the year. It is a simple and powerful way to spread the Gospel message, to be a light to our nation, and to create a Culture of Life in Canada.

When is Life Chain?
