#### Senators introduce Euthanasia bill

Senators Nancy Ruth (Conservative) and Larry Campbell (Liberal) have introduced S-225, a private member's bill that would amend the Criminal Code to legalize euthanasia and assisted suicide by lethal prescription. If S-225 passes, it would allow physicians to administer death to a wide-array of patients requesting it: anyone over the age of 18 who has an "illness, a disease or disability ... that causes the person physical or psychological suffering that is intolerable to that person and that cannot be alleviated by any medical treatment acceptable to that person." The language of the bill is similar to a pair of private members bill put forward by Conservative MP Stephen Fletcher earlier in 2014 that had almost no chance of reaching a vote in the House before this year's federal election. Fletcher, who was left a quadriplegic from a car accident in 1996, said he wants the ability to have a doctor help kill him when he chooses to die. In 2010, Parliament debated another private member's bill on euthanasia, C-384, and defeated it 228-59.

Alex Schadenberg, executive director of the Euthanasia Prevention Coalition, said the bill is "intentionally permissive" and that its "subjective" language shows "just how bad euthanasia and assistedsuicide bills can be." If passed, Canadians with disabilities or suffering depression would be susceptible to death by euthanasia. Schadenberg also said the bill aims to protect doctors who kill their patients, it is not about protecting patients; "There is nothing in this bill that would protect a vulnerable person," Schadenberg said.

## Report on abortion access pushes for RU-486

In late November, the Canadian Medical Association Journal published an article by Lauren Vogel critizing the lack of surgical abortion access in Canada, claiming that the presence of "underserved" parts of Canada require Health Canada to permit the importation and sale of the chemical abortion drug RU-486 (which goes by its medical name mifepristone). According to the Society of Family Planning 2012 survey of abortion services in Canada, 46 of Canada's 94 dedicated abortion facilities are located in Quebec and that 96% of abortions are surgical and committed in a clinical setting. Both the Society of Family Planning and Vogel call for increasing the availability of chemical abortions which they claim saves women from travelling, saves women from undergoing surgical procedures, and can be made available across the country. This information is not true. The reality is that women have died from taking this deadly drug. A 2011 report from the U.S. Food & Drug Administration (FDA) states that there have been 14 deaths associated with this drug. The same report identifies 2000 cases of adverse side effects including hospitalization, significant blood loss, severe infections, and blood transfusions. In Canada, drug trials were halted in 2001 after protests and the death of one woman from septic shock. A similar FDA report from 2007 revealed that 7.9% of patients needed surgery to complete the abortion

and/or to control bleeding. So much for safety and the elimination of surgical abortion.

Survey co-author Dr. Wendy Norman, Chair in applied public health research at the Canadian Institute of Health Research (CIHR) is a proabortion apologist who is

actively involved in promoting RU-486 for the Canadian market. She said, "top-notch" abortion access can only be achieved by making chemical abortion methods more easily available. CLC National Organizer Mary Ellen Douglas said both the Society's survey and the CMAJ article were "strictly pro-abortion pieces of propaganda," and that "the pro-abortion battle cry for the last 25 years has been 'we need more access'." While RU-486 is touted as safe, Douglas notes that there are often complications and women in remote areas would put their lives in jeopardy if they took the abortion pill but did not live near hospitals that could be life-saving when botched abortions or other serious sideeffects occur. RU-486 has been under review by Health Canada for several months, and due to their lack of transparency, Health Canada is refusing to provide any details on the process, keeping taxpayers and those concerned with this deadly abortion drug, in the dark.

#### **Ongoing federal nominations**

We continue to identify pro-life candidates at the local nomination level and help them get elected as Conservative Party candidates. We have worked with candidates in all parties but the NDP has long been officially pro-abortion and last May, Justin Trudeau announced that pro-lifers could no longer be candidates for the Liberal Party unless they agree to the party line. This makes getting pro-lifers nominated wherever we can for the Conservatives vitally important. We have worked with candidates all across the country, focusing on new candidates, although we certainly are also helping incumbents. Often we call supporters in a riding asking them to buy a party membership. To prevent the party from shutting down pro-life nominations, we do not publicize supportable candidates until after the nominations have closed (which is usually after the deadline for buying a membership). We encourage everyone to remain active in the political parties of their choosing to help select not just pro-life candidates, but pro-life executive members at the Electoral District Association level and to get pro-life policies debated within the party. We can only get pro-life people nominated if you get active in the political process.

#### March for Life 2015

#### New Brunswick expands abortion access

On November 26, New Brunswick Liberal Premier Brian Gallant announced that he was eliminating the province's abortion restrictions, thus paving the way for full taxpayer funding of abortionon-demand in the province beginning on January 1, 2015. For the past two decades, abortions were only funded in New Brunswick when they were okayed by a second doctor, thus effectively shutting abortions committed at the Morgentaler abortuary in Fredericton from receiving taxpayer dollars to kill unborn babies. But Gallant eliminated that requirement, as well as a regulation requiring a specialist to commit abortions. "We have identified the barriers and are proceeding to eliminate them in order to respect our legal obligations under the Supreme Court of Canada ruling and the Canada Health Act regarding a woman's right to choose," Gallant said in the statement. Now abortions will be paid for whether they are carried out in a hospital, doctor's office, or abortion mill. The Morgentaler abortuary closed in July after putting pressure on the provincial government to fund all abortions. There is no

indication that the Morgentaler abortuary will reopen following Gallant's announcement, but with the restrictions lifted, it is likely that abortion rates will increase in the province. In a CLC press release, Jim Hughes, national president of Campaign Life Coalition, said "Brian Gallant and the Liberal party of New Brunswick has caved in to the demands of a very loud minority of pro-abortion activists who unlike the majority of Canadians, support tax-payer funded killing of defenseless pre-born human beings."

#### Newfoundland abortion access

Newfoundland and Labrador Health Minister Steve Kent told the CBC he is looking at expanding abortion access across the province. With nearly 1000 surgical abortions committed each year in the province, pro-lifers say there is no shortage of killing preborn babies, but abortion advocates remain unhappy. They complain that women in the province must travel to St. John's to procure an abortion -- at either the Health Sciences Centre (hospital) or the private Athena Health Centre abortion mill, which used to be the Morgentaler Clinic. According to the CBC story, unamed abortion advocates call this a "barrier to access" and therefore an intolerable obstacle. Kent said he will consider requests to increase access, but admitted that so far there have been none. Abortion in Newfoundland is fully covered under the province's Medical Care Plan (MCP). Taxpayers also subsidize the travel costs for abortion-minded women via the Medical Transportation Assistance Program. #### Sex-ed Curriculum in Ontario

The Ontario government is committed to changing the sex-ed curriculum in the province -- we just do not know what those changes are. On December 12th a press conference was held in Toronto by a grassroots network of citizens demanding true and transparent consultation on the Sex-Ed component of Ontario's revised Health & Physical Education curriculum.

The network of parental rights advocates, multicultural groups, pro-family and faithbased organizations including Campaign Life Coalition criticized the Wynne government for hiding the Sex-Ed curriculum from parents and

conducting a "smoke and mirrors consultation process which pretends to find parental consent where none exists". The organizers accused the Wynne Liberals of lying about conducting a transparent and comprehensive consultation process. CLC obtained a copy of the survey questions which were used in the "consultation process" and it was a joke. The questions were vague, and provided no direction for the type of age-appropriate lessons teachers might provide students when it comes to sex-ed.

Although we do not know what the curriculum looks like due to the current government's secrecy, we can only assume that it will likely contain the same graphic and age-inappropriate sex-ed changes Dalton McGuinty's government tried to bring in four years ago, but was forced to abandon after parental and religious leader opposition. Those changes included promoting masturbation (Grade 6) and anal play (Grade 7) for elementary school children. Wynne was the education minister at the time. It's also very important to point out that Benjamin Levin, who was a key player in the formation of the last sex-ed curriculum when Wynne was the education minister, has been charged with seven counts of child exploitation, including charges of possessing and accessing child por**nography**. He is currently awaiting trial.

ACTION ITEM: Contact your local MPP, school board trustee, and your children's teachers and educate them on the issue. Other provinces, please be alert to similar anti-life/ anti-family initiatives in your area.

#### PC leadership race in Ontario

There are five declared candidates for the Ontario Progressive Conservative leadership. We are not yet ready to declare support for any candidate or candidates. We are trying to meet with all five leadership candidates and thus far, we have met with two candidates and have sent out questionnaires. Even if a candidate is not pro-life, there is still tremendous value in talking to them to share our concerns about pro-life issues (defunding abortion, conscience rights, euthanasia) and family issues (most notably education and parental rights) to see if there are areas in which we can work together. Patrick Brown, a federal MP from Barrie, has a perfect voting record on life and family issues. Monte McNaughton, an MPP from Lambton-Kent-Middlesex, has taken a leadership role in challenging the Liberal government on its sex-ed curriculum. The leadership vote is early May, so there is still plenty of time to evaluate the candidates, to get clarification from them, and to endorse or disqualify candidates based on their answers and actions over the next few months. But time is running out to buy a membership. The deadline is February 28, 2015. If you are an Ontario resident with any inclination to support the PCs, please sign up now. Memberships are \$10 or \$15, depending on if you submit an email address, and are available online at www. OntarioPC.com or through your local PC riding association.

Action Item: Contact the PC leadership candidates personally and ask them where they stand on life and family issues and if they plan on addressing these issues as leader of the party. Please inform CLC's political team of any discussions.

#### Bank of Montreal's Christian discrimination



In October 2014, in an email to its legal suppliers, leaked by the Institute for Canadian Values, the Bank of Montreal wrote that it will no longer

do business with law firms whose diversity standards are "not compatible" with the bank's. These standards include creating a more inclusive profession for LGBT lawyers and staff while at the same time discriminating against legal suppliers who uphold traditional family values. As a way to push forward their anti-christian agenda, BMO established a group called Legal Leaders for Diversity (LLD) which exists for "promoting diversity in the workplace". The group's mission, according to its website, is to "support vendors and suppliers whose ownership or employee base reflects a commitment to diversity and inclusion." In other words, if you don't support the banks socio-political agenda, you will be discriminated against, and according to them, that is perfectly fine. This will not only affect how the bank deals with vendors but it will also have a lasting effect on their hiring practices. Before opening a new bank account, we suggest you shop around and eliminate the Bank of Montreal from your consideration.

#### **New CHP leader**

In November, the Christian Heritage Party selected Rod Taylor as their new leader. More than 150 attended the biennial convention in Hamilton, Ont., and more than 400 people attended their banquet. The CHP is the only federal party committed to legal protection of the unborn from the time of conception (fertilization) until natural death. We are very pleased to hear that Taylor wants the CHP to focus on ridings where there are not (in his words) "pro-life heroes" already sitting as MPs. It does not make sense for the CHP to challenge sitting MPs who have demonstrated a will to bring legal protection to the unborn. We look forward to working with Taylor and CHP candidates as they bring a principled, pro-life option to voters across the country
