### **Euthanasia numbers in Canada**


CTV reported that 744 people have been killed by euthanasia in Canada since it it was legalized on June 17, 2016. That was in six months, and doesn't include those who received permission from a court to be killed by a medical professional before euthanasia and doctor-assisted suicide were legalized. About 40% of the deaths were in Quebec, which permitted the procedure six months earlier. Alex Schadenberg, executive director of the Euthanasia Prevention Coalition (EPC) says those numbers are surely under-estimating the scope of the mass killing by euthanasia because CTV admits the data upon which its report was based is incomplete and that there is a good chance there is under-reporting of the practice. The EPC's Amy Hasbrouck says that Quebec euthanasia commission numbers indicate that 14% of medically induced killings by

physicians or other "healthcare workers" are not in compliance with the province's laws regulating the practice. The EPC also has reports of unintended victims of euthanasia. University of Toronto law professor, Trudo Lemmens, told CTV that the provinces should be releasing more data to protect patients from possible abuse, arguing that more information could protect the vulnerable: "There is a concern that people who are vulnerable or who find themselves in a situation of vulnerability may be pressured consciously or unconsciously to opt for medical assistance in dving either because of financial circumstances or because the medical help that they need is not necessarily available." Lemmens argues that the current data being collected - the medical condition, the age, the gender - are submitted by the medical practitioner who carries out the death. This is insufficient, Lemmens says, and calls for health ministries to collect information from family members and friends of the deceased to better shine a light on the practice. One euthanasia death is




too many, but we are very disturbed by the extent that Canadians have accepted euthanasia as legitimate health care. As time goes on and euthanasia is normalized in the culture, we can expect these numbers to dramatically increase. In the Netherlands and Belgium, which have similar laws governing euthanasia and assisted-suicide, about 5% of all deaths are aided by health professionals under the guise of compassion and mercy. If similar rates were applied to Canada's roughly 250,000 annual deaths, we would expect euthanasia deaths to total 12,500 annually in a few years. Unless the public and politicians wake up, and the culture changes, that is very likely to happen.

### CPC leadership update - We need you!

The Conservative Party of Canada will soon be choosing its leader and we need you to be part of this process. To vote in the mail-in preferential ballot in May, one must be a member by March 24. Because there are two principled pro-lifers in the race and we have been reassured by both of them that they will remain in the race, we are encouraging our supporters to sign up as members as soon as possible. Don't wait until the last minute - so many things can go wrong (problems with the internet, getting busy and forgetting, etc). Both Saskatoon MP Brad Trost and former Ottawa-area MP Pierre Lemieux deserve our support because they have been raising the life issues on the campaign trail and neither have apologized for their pro-life voting record and views. Trost has raised conscience rights and traditional marriage while Lemieux said if he was elected prime minister, he would do something about sex-selective abortions. To vote in this leadership race is simple. It's a mail-in ballot, so there is no expensive convention to attend. You can vote for as many supportable candidates as there are running with the preferential ballot. We encourage everyone to take out a \$15 membership in order to vote for the pro-life candidates; while we hope one of them wins, a loss with sufficient support sends a strong signal to the party, the media, and the public that social conservatives are an important constituency that cannot be ignored. There may be other candidates that we cannot endorse but which you might determine are worth putting lower on their preferential ballot.



Last month, Milton MP Lisa Raitt was interviewed by CTV's Don Martin and was asked about abortion. She said: "My mother had me and was going to give me up for adoption. She chose not to have an abortion, so I have some really personal views about it." The leadership contender added, "I think it's a decision that is a tough decision for any woman to make, but I would never bring in legislation to make it illegal, ever." Raitt obviously raised some doubts about abortion ("a tough decision") and implies she could just as easily have been aborted had she been conceived a year later (she was born in 1968). That makes her refusal to ever make it illegal that much more baffling. CLC has given Raitt a red-light on its ratings because she is unsupportable. She voted against the 2012 Stephen Woodworth motion to study when human life begins and supported other socially liberal bills.

With the exception of the Raitt interview, social issues have not really been an issue during the Conservative leadership campaign over the past month. It is too early for such considerations but we are examining each candidate's voting record, public statements, and positions on issues such as free votes to determine which ones a pro-lifer could make a prudential vote for and which ones are completely disqualified from pro-life support. We will provide this information as the leadership election gets close.

Action Item: If you haven't already, please consider taking out a membership with the Conservative Party of Canada in order to be eligible to vote for both Brad Trost and Pierre Lemieux.

### Third-party calls

You may receive a call from a third-party enquiring about your Conservative or Progressive Conservative membership status and to urge you to vote for a leadership or local candidate. Some of you have contacted us concerned about these calls, whether or not they are really from Campaign Life Coalition. From time to time we must contract a call centre to make a large number of calls on our behalf to encourage people to get involved in specific political strategies. Some of you raised the concern that the calls were for Brad Trost and not Trost and Pierre Lemieux, considering that CLC is promoting both of them. Indeed, a series of calls were made on behalf of only one candidate because it was their campaign that took out an advertisement in *The Interim* with follow-up calls. We regret if this caused you concern. Your names are not being sold to third parties and are not being shared with the candidates without your consent. The call centres acting on our behalf follow stringent rules to ensure the privacy of the information. We do this to provide information about pro-life candidates and ensure that action can be taken swiftly. This is doubly true in local nomination races, which are often called just a few weeks before nomination meetings, and it often isn't possible to communicate this effectively through the mail and CLC National News.

## Radical sex-ed through a Catholic lens?

When the Ontario Liberal government's controversial 2015 Health & Physical Education curriculum came out, amidst protests and province-wide parental opposition, parents with children in the

Catholic school system were reassured by bishops, trustees, and educational leaders that the document's learning expectations would be taught successfully in Catholic schools through the perspective of a 'Catholic lens'. The Institute for Catholic Education (ICE) was handed the responsibility to come up with an appropriate curriculum guideline for Catholic schools.

One must remember that the successful delivery of all curricula ultimately is contingent on the abilities, professionalism and commitment of the classroom teacher. In this particular case, faithful implementation depends on the proper faith formation, effective understanding and personal comfort level of the individual teacher, given the delicate nature of the curriculum material.

As expected, there are several problems with the ICE document. In general, the flaws of the document include the following: acceptance of a too secular/humanist view of the human person; uncritical acceptance of the language and uncorroborated assumptions regarding gender theories as found in the provincial HPE document; limited respect for parental rights in the introduction of some sensitive themes or notions; a limited sense

of social justice issues; apparent willingness to place sensitive topics at age-inappropriate grade levels (along with too graphic aspects of certain explanations); key church teachings compromised by the context and demands of the HPE curriculum. In the Appendix, the writers of the document make a strange recommendation of resources that teachers could consult and could direct their students to go look at to obtain information about certain organizations that are trying to "improve the quality of life" across the planet. We were shocked to see International Planned Parenthood Federation (IPPF), the world's largest promoter of abortion and so called 'sexual rights' for young people, among recommended organizations. Either the writers are ignorant about the full scope of the activities and policies supported and promoted by these organizations or they deliberately are intent on sowing more confusion and legitimizing questionable conduct contrary to Catholic teaching. Sadly organizations such as Well's for Life, Canadian Food for Children, MaterCare etc were ommited. Is this really what the bishops had in mind when they reassured parents of a 'Catholic lens'?

# Quebec couple aborts late term baby because of disability

Dr. Yves Robert, secretary of the Quebec College of Physicians, told reporters just before Christmas that women should "have access to it without real problems." The "it" Robert was referring to was late term abortions. His comments came after a media-fury that a woman was refused a 30-week abortion at two Montreal hospitals before a third finally agreed to commit the late-term abortion at 35 weeks. On paper, the College restricts abortion to 23 weeks but gives abortionists permission for "exceptional" cases such as "serious congenital anomalies" in the preborn. The problem, of course, is that almost all late term abortions are for the "exceptional" circumstances. Few people choose to kill their preborn children in the third trimester unless there is a reason: the health of the mother, the health of the child, the future health of the child.

The unidentified woman told a Montreal newspaper she had to "fight" to get an abortion after she and her partner discovered "abnormalities" with the preborn child. She said, she "didn't want my child to suffer their whole life [sic]." McGill sent the issue to an executive committee, which refused the woman's request. Another hospital refused and after the parents got their lawyer involved, a third hospital eventually killed their child at 35 weeks. The lawyer, Jean-Pierre Menard, went to the press to complain: "The decision to continue or interrupt a pregnancy belongs only to the woman. No committee, no outside authority." As a matter of law and medical ethics, this is simply not true. Putting aside (for a moment) the killing of the child, doctors can make medical judgments and decide that a certain procedure is not in the best health interest of the patient or that he or she might not want to be involved. Years ago, Henry Morgentaler told journalists he doesn't do late-term abortions because at that point, it was killing a child. Media reports suggested that all women seeking late-term abortions in Quebec and Ontario were sent to the United States. Provincial health plans paid for the procedure even though no Canadian doctor would do them. This is not necessarily a moral position, but a medical liability issue. As a pregnancy progresses, the health risks such as hemorrhaging and infection increase.

# Parental rights battle continues in Ontario

If you read the newspapers or watch your local TV news, you may think that the opposition to Kathleen Wynne's radical sex-education curriculum has come to an end, but the truth is, parents are still fighting this social engineering campaign by the current Liberal government. starting to pop up. In addition to ongoing parental protests that are taking place at MPP constituency offices, and CLC's ongoing efforts to nominate and elect candidates who oppose Wynne's sex-ed, the Canadian Families Alliance (of which CLC is a partner) will soon be launching a postcard campaign targeting households in specific ridings with the goal of educating tens of thousands of parents who are blissfully unaware of what's actually in the curriculum, nor of the involvement of a sexual predator in its writing. As we have reported previously, Ben Levin, the former deputy education minister, is currently serving a 3 year prison sentence for child porn and pedophiliarelated crimes. CLC is also supporting an appeal to a higher Ontario Court by the Hamilton father who sued his public schoolboard for the right to withdraw his children from radical sex-ed lessons. After Wynne re-introduced the despised curriculum in 2015, she and her then Education Minister attempted to pacify outraged parents and quell the growing opposition by repeatedly promising "If you don't agree with some element of the new sex ed, you can opt your child out of that class". However, once implemented, Wynne reneged on that promise and actually sent government lawyers to argue in court that the Hamilton father should not have the right to withdraw his kids, nor even to be told in advance what they would be taught. Her lawyers convinced the lower court judge, but we're helping the father to keep fighting until victorious.
