AMENDMENT #	WORDING
#2: Article 2 – Statement of Principles	ADD (new clause) 2.1 (i): We recognize that parents are the first and primary educators of children
#3: Article 6 – Riding Associations	ADD to 6.2: Neither the Leader nor the Party Executive, nor the PC Ontario Fund nor the PC Caucus nor a local riding executive nor any other committee has the power to select a PC candidate. In the rare circumstance...where a nomination convention is not feasible... Party Executive is authorized to develop nomination rules allowing the Party membership in a Riding Association to select that riding's candidate by electronic means, using the technology available at that time.
#4: Article 6 – Riding Associations	ADD to 6.3: It is through such an open, public and democratic vote that the local membership of the PC Party shall select its candidate.
#5: Article 6 – Riding Associations	ADD (new): 6.8 Each PC member eligible to vote in a candidate nomination convention shall be provided with a minimum 45 days notice of the.... nomination convention.
#6: Article 7 – Membership	ADD (new): 7.5 payments of a membership shall be done by personal cheque or credit card, the foregoing which may include payment on behalf of family members of the same household. Payment of a membership by cash... shall not be permitted.
#20/21: Article 15 – Special General Meeting	Add to 15.2: "Such a Special General Meeting shall be held within 120 days following the receipt of such a petition."

AMENDMENT #	WORDING
#21/22: Article 18 – Policy Conferences	18.1 Current Wording: The Executive shall call a Policy Conference at least once a year... Replace “Once a year” with “every two years”
#22/23: Article 18 – Policy Conferences	ADD (new): 18.8 Any party of the policy development process that involves an online, web-based system shall be in addition to, and not in replacement of, the requirement to hold an in-person policy conference as outlined in paragraph 18.1.
#26/27: Article 23 – Interim Leader	23.1 Add: The Interim Leader shall be ineligible to be a candidate in that particular Leadership Election
#27/28: Article 24 – Leadership Review	24.1 Current Wording: ...following an Ontario General Election in which the Caucus does not form the Government of Ontario, and only at such meeting, the delegates shall be asked by secret ballot: “do you wish to have a leadership election?” Delete the words “in which Caucus does not form the Government of Ontario”
#29/30: Article 24 – Leadership Review	ADD (new): 24.3 The Party Executive shall also be authorized to call a leadership election: (a) Upon receipt of a petition from at least 50% of the Ontario PC Caucus... or (b) Upon receipt from at least two -thirds of Ontario PC Riding presidents... or (c) Upon receipt of a petition signed by at least two -thirds of Ontario PC Riding Associations...
#30/31: Article 24 – Leadership Review	ADD (new): 24.4 The Party Executive shall be required to call a leadership election upon receipt of a petition calling for a leadership election from at least 50% of the Ontario PC Caucus if such petition is also received from two-thirds of Riding Presidents.
